2. SIGNIFICANT ACTIVITIES:

83-21-00943 AGGRAVATED ASSAULT: Jilted lover rammed her ex-boyfriend's car on East Penn property during a shift change. Operated #1 was charged with Aggravated Assault and related offenses.

83-21-00878 ASSIST OTHER AGENCY: NBRPD was investigating a head on crash with fire that had occurred on 222 at Pleasant Hill Rd which backed traffic up into Richmond Township and Fleetwood Police assisted with traffic control while the scene was stabilized.

83-21-01103 ASSIST PSP: Provided an initial response and handled a mental health related call for PSP. The call involved a hostile patient at the Topton Home.

83-21-01053 ASSIST PSP: Provided backup for a Trooper investigating a domestic disturbance in Ruscombmanor Township.

- **83-21-00952 CHILD ABUSE:** Police responded to a report of child abuse at a Fleetwood Borough residence. No sign of injury was present, and the matter was referred to CYS for further investigation.
- **83-21-01098 MCSAP INSPECTION**: A dump truck was stopped for speeding in Topton Borough and a subsequent commercial vehicle inspection identified 3 additional violations and the driver was cited for them as well as for speeding.
- **83-21-00887 COMMUNITY SERVICE EVENT:** The Chief and Sergeant participated in a coffee with a cop event in Fleetwood Borough that was well attended.
- **83-21-01084 DUI:** A subject was found slumped over his steering wheel at the Walnuttown Rd RR crossing. The subject had apparently passed out while-waiting for traffic to move in front of him. An open beer can was found in his console and after failing field sobriety test the subject was transported for a breath test which yielded a result nearly 3x the legal limit.
- **83-21-00897 FIRE:** Police responded to a reported house fire in Richmond Township. The fire was investigated and found to likely have not been of suspicious origin. Of note, when the neighbor found the house on fire, he didn't know that if the homeowner was home, so he forced entry and found the house vacant except for the owner's dog which was laying on the floor. He took the dog outside and began resuscitation efforts which proved successful.
- **83-21-00895 MOTOR VEHICLE CRASH DUI RELATED:** Police responded to a crash where the driver was trying to get away. Police arrived on location and found the striking vehicle a short distance from the crash site and unoccupied. The driver was found lying in a field and exhibited classic signs of intoxication. Charges pending receipt of lab results.
- **83-21-01043 RAPE:** Police are investigating the reported rape of an adult female by her biological father at their Richmond Township residence. All parties were identified and interviewed. Potential charges pending the processing of the rape kit.
- 83-21-00983/1019 ROBBERY: Police were dispatched to a Ruscombmanor Township residence where a reported home invasion type robbery had just occurred. Upon arrival police discovered that the victims were manhandled, free of injury and had money and medications stolen. Investigation identified the coordinator of the crime and had a warrant issued for his arrest. He was picked up on the open warrant in short order by another department who had stopped him for a traffic violation. The subject was transferred to Fleetwood Police Custody and attempted to eat packets of drugs when placed in the holding cell. Investigation continues.
- **83-21-00880 STOLEN VEHICLE:** A vehicle was taken for an unauthorized joy ride by unknown persons and returned to a location near by where it was taken. Investigation continues.
- 83-21-00982 THEFT: Police are investigating a large theft of a significant amount of money transferred out of the victim's bank account.
