2. SIGNIFICANT ACTIVITIES:

83-21-01678 ARSON: Police are investigating someone throwing a bag of fireworks against a Richmond Township residence which charred the building's exterior.

83-21-01818 DOMESTIC ASSAULT: Police are investigating a domestic assault that was discovered when police were approached to assist with serving a PFA order at a Fleetwood Borough residence.

83-21-01471 ASSAULT: Police responded to a Fleetwood Borough rental property where someone was allegedly holding a knife to some's throat. Investigation found the premise to be unoccupied and likely an exaggerated accounting of events had occurred.

83-21-01605 FRAUD: Police assisted a NY police department with an investigation involving a Ruscombmanor Township resident who was a suspect in their investigation. Investigation determined that the subject was actually a victim of fraud himself.

83-21-01800 BURGLARY: Police investigated a reported burglary to a rental property in Fleetwood. Once inside the residence the actor(s) engaged in some minor vandalism, but nothing

- was stolen. Investigation determined it was likely an incident involving a scorned lover, but an actor could not be positively identified.
- 83-21-01542 CRIMINAL TRESPASS: Police responded to a report of an unauthorized subject being at a rental property in Richmond Township. The male was the subject of several police contacts of increasing intensity throughout the month and was ultimately arrested and incarcerated in BCJ in lieu of posting bail.
- 83-21-01812 DRUG POSSESSION: While on patrol in Ruscombmanor Township, police noticed a subject parked partially blocking a lane. Investigation determined the registration on the vehicle was suspended and the operator was in possession of marijuana and related paraphernalia. Charges to be filed for drug and motor vehicle offenses.
- **83-21-01512 DUI:** While on patrol an officer observed a vehicle being driven erratically and found the operator the be intoxicated. Subject was arrested and processed for DUI related charges.
- **83-21-01547 DUI:** Police responded to a report of a vehicle operator acting strangely at a Fleetwood Borough business. Upon arrival police found the subject passed out with his car running and in reverse. Subject was arrested and processed for DUI related charges.
- 83-21-01540/1541 FRAUD: Police were contacted regarding a suspected contractor fraud situation involving 2 Topton residents. A roofing contractor had collected over \$4,000 from two residents several months ago and had not yet started any work. The residents reported their attempts to contact the company failed. Investigation determined the contractor was incarcerated for unrelated issues and has such the DA's Office advised charges were not appropriate for contractor fraud in this case.
- 23 reports of various types of fraud attempts were made to police during the month of June.
- **83-21-01721 HARASSMENT:** Police responded to a report of possible witness intimidation at a Richmond Township residence regarding an ongoing narcotics investigation. Individuals involved were identified and the investigation is continuing.

Police responded to 8 mental health calls resulting in subjects being taken into custody for mental health evaluations without incident. (3 Fleetwood, 5 Richmond Township)

- 83-21-01493 MVAR DUI: Police investigated a Richmond Twp crash were the operator of a vehicle tried to show off, lost control of his vehicle and struck another vehicle before crashing into a utility pole and becoming disabled. The driver was found to be driving with a suspended license, DUI related, and was charged accordingly.
- 83-21-01820 MVAR DUI: Police investigated a crash where an impaired driver lost control and struck a utility pole on Fleetwood Lyons Rd. Subject charged accordingly.
- **83-21-01742** MVAR DUI: Police investigated a crash where an impaired driver lost control on SR 222 and became disabled in a corn field. Subject charged accordingly.
- **83-21-01576 SEX OFFENSE:** Police are investigating several sexual assaults reported between juveniles at a Ruscombmanor Township address.

83-21-01702 SEX OFFENSE: Police are investigating a possible instance of sexually related offenses being conducted via the internet. The information was reported to a Richmond Township business.

83-21-01733 THEFT: Police were notified that an elderly customer from Fleetwood Bank was withdrawing in excess of \$20,000 from her bank account in a series of withdrawals which seemed suspicious. Investigation determined the woman was likely a victim of fraud, but she provided false information to police and refused to assist with further prosecution. Berks Office of Aging was made aware of the investigation.

83-21-01476 THEFT: Police are investigating the theft of \$240 from a wallet left inside of a shopping cart at Boyer's Market.

9 MCSAP inspections were conducted 2 instance found no violations and citations were issued associated with the other 7, none of which resulted in vehicles/drivers being placed out of service.
