2. SIGNIFICANT ACTIVITIES:

83-21-01404 ASSAULT: Police responded to a father vs son domestic at a Virginville residence. Investigation determined that a verbal argument escalated to the point where the son assaulted his father and was subsequently placed under arrest. Incident to his arrest the son was found to be in possession of a small amount of marijuana and related paraphernalia.

83-21-01310 DOG BITE: Police investigated a reported dog bite in Tipton Borough. A resident reported that while gardening, a neighborhood dog came onto his property and bite him in the ankle. The dog owner failed to produce required proof of vaccinations and received 2 citations for violations of {A Dog Law.

83-21-01263 DOMESTIC: Police Responded to a reported domestic disturbance at a Richmond Twp residence where one of the parties made comments about not wanting to live. Mental health services responded to the scene and took over interactions with the despondent male after police completed their investigation of the argument.

83-21-01193 DRUG POSSESSION: Two juvenile males were discovered smoking marijuana in the main park bathroom and were charged with curfew violations and possession of a small amount of marijuana and related paraphernalia.

83-21-01344 DRUG POSSESSION: Police observed a vehicle following motorcycles too closely in Fleetwood Borough and initiated a vehicle stop. It was determined that the driver was wanted for a probation violation and incident to his arrest marijuana and related paraphernalia was seized. The subject was transported to CPC and turned over to the Sheriff's Office for the outstanding warrant and a complaint was filed later for the additional traffic and drug related charges.

83-21-01256 MENTAL EALTH WARRANT: Police responded to a Fleetwood residence where a male appeared to be attempting to break in. It was determined that the subject was having a mental health crisis and was taken into custody and transported by ambulance for an evaluation.

83-21-01229 RECKLESS DRIVER: Police responded to a report of a reckless driver in the area of 662 and 222. Police were unable to locate the vehicle and then were called and advised the elderly female driver was disoriented and found driving the wrong way in the roundabout and was stopped and escorted to Kutztown Auto. Police made contact with the family from Philadelphia area, and they responded to picked up the driver. The car had evidence of a possible minor crash and as of today bolos have not identified any hit & run crashes in the area consistent with the damage on her vehicle.

83-21-01305 SEX OFFENSE: Police investigated the claims of a Topton resident that a young child was molested by an older cousin, still a juvenile. Investigation determined that both children are actively engaged in counseling regarding their conduct and CYS was notified about the complaint.

Commercial Motor Vehicle Inspections: 15 completed, 5 vehicles/drivers placed out of service. 6 found with no violations, several citations/warnings issued.
