2. SIGNIFICANT ACTIVITIES:

83-21-03000 ASSAULT: Police are investigating an alleged home invasion and assault that occurred at a Fleetwood Borough residence. The investigation identified several suspects who were known to the victim.

82-12-0341 ASSIST OTHER PD: Police assisted with traffic control in regard to an accident and vehicle fire that closed 222 in Maidencreek Township. The incident caused an unusually large volume of traffic to flow through Fleetwood Borough and Richmond Township throughout the morning of 10/18.

83-21-03057 ASSIST PSP: Police responded to assist PSP with a fire at East Penn manufacturing. The fire was fueled by plastic battery cases and it's plum could be seen for miles. The fire was discovered to be in a corner of the property that lies in PSP jurisdiction.

- **83-21-02921 BURGLARY:** Police were called to investigate a reported burglary at a Fleetwood Borough residence. Investigation indicated that this incident may have been associated with ongoing domestic issues amongst the 2 tenants.
- **83-21-03026 CHILD ABUSE:** Police were notified of a complaint involving a possible instance of physical abuse by a teacher at Willow Creek Elementary School. Investigation by police and school district officials determined the incident couldn't have happened as the child reported. The child later recanted and said the story was told because the student didn't like the teacher.
- **83-21-03039 CHILED ABUSE/HOSTILE WORK ENVIRONMENT:** Police are investigating third party claims that an employee at a Richmond Twp business may have had inappropriate contact with a minor about a year ago.
- 83-21-02972 COMMUNITY SERVICE: Fleetwood Police planned and directed the police response that supported the annual Topton Halloween Parade. Several thousand people attended, and no major incidents were reported. An after action report was presented to borough officials after the parade and Chief Stinsky met with the Borough Manager to discuss planning of future events.
- **83-21-02988 SUSPICIOUS ACTIVITY:** Police responded to a report of a suspicious male on the property of a Keller Rd residence. The male presented with some possible mental health issues and was found to be a resident of the property facing an eviction.
- **83-21-03176 FRAUD:** Police are investigating a report that an elderly resident was defrauded of approximately \$5,000.00 through an elaborate telephone and computer scheme.
- **83-21-03094 DUI RELATED CRASH:** Police responded to a Ruscombmanor Twp bar where an intoxicated woman reportedly fell off a bar stool and then struck a parked vehicle when trying to leave the premise. The woman was taken into custody on suspicion of DUI charges.

3. PERSONNEL:

Three Officers received crisis negotiator training that was held at the Fleetwood Grange last week with officers attending from around the state. Because the department hosted the training 2 of the 3 officers attending attended at no cost to the department.

Officer Ruiz returned to full duty from maternity leave.

Chief Stinsky's last day in charge of department operations was Friday 11/5.

4. EQUIPMENT:

The department took possession of the new police vehicle and the process to transfer equipment from the Ram pickup and sell it to the fire department has been initiated.

5. PROJECTED ACTIVITIES / ISSUES:

The selection process for a new police chief has begun and is being administered by borough officials.

Ten applications were received as a result of advertising for the police civil service full time selection process. This process was undertaken in order to generate a new list of potential full time police officers. The physical fitness and written test are scheduled for Sunday 11/21/21.
