2. SIGNIFICANT ACTIVITIES:

In April of 2025, the Fleetwood Police took reports in Ruscombmanor Twp for 2 disorderly Conduct complaints.

One Disorderly Conduct complaint resulted in an arrest and charges were filed against 2 males for assault following a road rage incident that occurred last month.

On 08/28/24 at approx.. 2357 hrs, The Fleetwood Police responded to Field Crest Court for a report of shots fired. Officers arrived and initially were unable to locate any evidence of a shooting. Shortly thereafter, officers were summoned back to the area for a report of an occupied residence that sustained damage from bullets being fired into it. Officers were able to determine that approx.. 10 rounds had been fired into the residence. Multiple officers from the department assisted with canvassing the neighborhood, obtaining surveillance footage of the incident and going door to door interviewing residents. Through further investigative methods and many investigative hours, a subject of interest was developed. Further investigation and an interview of the subject resulted in a 32 year old male of Shoemakersville, confessing to the crime. The male was unable to provide a reason for the random act of violence which had no connection to the homeowners.

On 5/1/25, charges of Discharge of a firearm into an occupied structure, possessing instruments of crime, Reckless endangering of persons and Criminal Mischief were filed against the male.

Special recognition to Cpl. Angela Arndt and Criminal Investigator Keith Merkel for their many hours of dedication to the case and subsequent arrest.

3. PERSONNEL:

Currently 2 part time officers, Callan Cress and Joel Avram, have been offered positions. Both are in the final stages of the hiring process and will start training with the department. Both come to us with police experience. 1 additional applicant is currently in the background stage of the hiring process.
